DECLARATION OF CONFLICT OF INTEREST FORM (MUST ACCOMPANY ALL SUBMISSIONS)

Conflict of interest exists when professional judgment concerning a primary interest (such as patients' welfare or the validity of research) may be unduly influenced by a secondary interest (such as financial gain or personal rivalry). It may arise for the authors of a JID article when, for instance, they have a financial interest or a strongly held opinion that may influence—probably without their knowing—their interpretation of their results.

We believe that to make the best decision on how to deal with your paper we should know about any such conflict of interest you may have as authors of this paper. We are not aiming to eradicate conflict of interest, and it is by no means a crime. We will not reject papers simply because you have a conflict of interest, but we may decide that our readers should know about it. In that case we would discuss it with you before publication.

Conflict of interest can take many different forms, and we cannot hope to cover them all in a simple list. We ask you, though, to consider whether there is something that would embarrass you if it became generally known after publication. The following list gives some examples of

possible conflict of interest.

- (a) Employment by, consultancy for, share ownership in, or any close relationship with an organization whose interests, financial or otherwise, may be affected by publication of your paper.
- (b) A close relationship with, or strong antipathy to, a person whose interests may be affected by publication of your paper.
- (c) An academic link or rivalry with somebody whose interests may be affected by publication of your paper.
- (d) Membership in a political party or special interest group whose interests may be affected by publication of your paper.
- (e) A deep personal or religious conviction that may have affected what you wrote and that readers should be aware of when reading your paper.

We ask that you and your coauthors let us know of any such possible conflicts of interest. It is now our policy to state at the end of each paper whether a conflict of interest exists, and if so, what this is. **Please sign the form below and include it with the submission of your article to the JID. All authors of your paper should sign (please photocopy this information for your coauthors).**
